Every class entry at a UHCA competition shall constitute an agreement and affirmation that all participants (which included without limitation, the owner, lessee, trainer, manager, agent, coach, driver, handler, rider and the horse) for themselves, their principle, representatives, employees and agents; (1) Agree to hold the competition, its managers, officials, employees, and agents, the facility owners and operators, and the UHCA and its Board of Directors harmless for any action taken; and (2) Agree that they participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk of serious injury or death, in participation they expressly assume any and all risks of injury, illness, or loss, and they agree to indemnify the UHCA and its Board of Directors harmless from and against all claims including for any injury, illness, or loss suffered during or in connection with the competition, whether or not such injury, illness, claim or loss resulted, directly or indirectly from the negligent acts or omissions of said competition, its employees, and agents, or the facility owners and operators. **WARNING:** Under Kansas/Missouri Law, there is no liability for an injury to or the death of a participant in domestic animal activities resulting from the inherent risks of domestic animal activities, pursuant to section 1 through 4. You are assuming the risk of participating in this domestic animal activity. K.S.A. 60-4001 through 60-4004.
